Interest Rates and Interest Charges

How We Will Calculate Your Balance: We use a method called "average daily balance (including new purchases)." See your account agreement for more details.

Billing Rights: Information on your rights to dispute transactions and how to exercise those rights is provided in your account agreement.

How We Will Calculate Your Variable APRs: We will add a "Margin" to an "Index Rate" to determine your variable interest rates. For each billing period the Index Rate we will use will be equal to the Prime Rate reported in the Federal Reserve Bulletin on the first day of the month preceding the month in which the rate will take effect. The Index Rate as of o1/o1/16 is 3.50 percentage points. The "Margin" for purchases and balance transfers will be 6.90 to 9.90 percentage points based on your creditworthiness. The "Margin" for cash advances will be 9.90 to 12.90 percentage points based on your credit worthiness.
