LANPASS Visa Signature® Card Terms and Conditions

IMPORTANT INFORMATION ABOUT PROCEDURES FOR OPENING A NEW ACCOUNT: To help the government fight the funding of terrorism and money laundering activities, federal law requires all financial institutions to obtain, verify and record information that identifies each person who opens an account. What this means for you: When you open an account, we will ask you for your name, physical address, date of birth and other information that will allow us to identify you. We may ask to see your driver's license or other identifying documents.

We may change APRs, fees, and other Account terms in the future based on your experience with U.S. Bank National Association and its affiliates as provided under the Cardmember Agreement and applicable law.

We apply your minimum payment to balances with lower APRs first, including promotional APRs. Amounts paid over the minimum payment will be applied in the order of highest to lowest APR balances.

If you are eligible, you will receive the LANPASS Visa Signature Card. If not, you will be considered for the LANPASS Visa Card.

If you are granted an Account, the following rates on the Account are variable: Non-Introductory Purchase Rate; Non-Introductory Balance Transfer Rate; Cash Advance Rate. understand and agree that we will report that fact, your name, address, e-mail address, phone number and information about your ongoing account activity to LATAM Airlines, but will not disclose to LATAM Airlines any other information about you taken from this application or received from third parties. By submitting this application, you certify that you read and understood the disclosures here and you agree to the terms of this application.

EXPANDED ACCOUNT ACCESS: Any Card or PIN issued to or selected by you under this Agreement can be used to access multiple checking, savings, line of credit and credit card account(s) held in your name with us or our bank affiliates; and any account you open with us and our affiliates may be accessed by the Card or PIN issued under this Agreement now or in the future. "Expanded Account Access" means use of a card or account number and PIN to conduct a transaction or obtain information at ATMs, over the telephone, through personal computer banking, or via any other available method. If the Card or PIN is for a joint account, the Card or PIN can be used to access all the accounts linked to the Card or PIN Access, whether joint or individual. There are no additional fees or charges for Expanded Account Access, but fees applicable to each applicable account will continue to apply in accordance with the terms of the applicable account agreements. Call Cardmember Service at 800-274-7200 to cancel Expanded Account Access, allowing a reasonable time for cancellation to become effective. If you cancel Expanded Account Access for any account, this Account will not be accessible by any card or PIN other than the Card or PIN issued under this Agreement.

Rewards are not earned for Advances (including wire transfers, travelers checks, money orders, foreign cash transactions, betting transactions, lottery tickets and ATM disbursements), Convenience Checks, Balance Transfers, Interest Charges and Fees, credit insurance charges, or transactions to fund certain prepaid card products.

All future cardmember communications will be in English (also in Spanish when possible). In the event of discrepancy between the English and Spanish languages on this document, the English version will prevail.

LATAM Pass REWARD PROGRAM

The term "LATAM Pass Account Number" refers to the frequent flier number assigned to you and used by LATAM Airlines or its affiliate carriers to administer the Miles in the LATAM Pass Program. The term "Account" used by itself shall represent the LANPASS Visa Credit Card Account.

Account must be open and in good standing to earn and redeem miles.

(a) We will request that LATAM Airlines award two LATAM Pass Miles ("Miles") to your LATAM Pass Account for each dollar of Net Purchases on your Card for qualified LATAM Airlines Purchases made during a billing period as long as your Account is not 5 days or more past due or overlimit at the close of your billing period. We will request that LATAM Airlines award one (1) Mile to your LATAM Pass Account for each dollar of Net Purchases on your Card for all other purchases (Non-LATAM Airlines Purchases) made during a billing period as long as your Account is not 5 days or more past due or overlimit at the close of your billing period. Account must be open and in good standing to earn miles. Please refer to your Cardholder Agreement for additional information. We will not award Miles for Advances (including wire transfers, travelers checks, money orders, foreign cash transactions, betting transactions, lottery tickets and ATM disbursements), Convenience Checks, Balance Transfers, and Fees, credit insurance charges, transactions to fund certain prepaid card products, U.S. Mint purchases, or transactions to purchase cash

convertible items. However, from time to time we may request Miles for special promotions. We reserve the right to adjust the amount of Miles requested from LATAM Airlines for Purchases or to stop requesting Miles for Purchases on the Account, upon notice to you.

- (b) "LATAM Airline Purchases" means purchases directly from LATAM.com, LATAM Airlines S.A. or its affiliate carriers including LATAM Airlines Peru S.A., Aerolane, Lineas Aereas Nacionales del Ecuador S.A. d/b/a LATAM Airlines Eduador, LATAM Airlines Argentina S.A. or any other carrier that becomes part of the LATAM Pass program. "Net Purchases" for a billing period are determined by adding all new Purchases (LATAM Airline Purchases and Non-LATAM Airline Purchases) recorded to your Account during the billing period and subtracting any credits and chargebacks to a merchant that have been recorded to your Account during the billing period for returned Purchases. If credit for returned charges exceeds new Purchases in any billing period, the excess credit will be carried forward into successive billing periods and subtracted from future new Purchases to determine the new Purchases for those successive periods. We may round Net Purchases up or down to a whole dollar amount for purposes of awarding Miles.
- (c) Participation in LATAM Pass is subject to the terms and conditions of LATAM Pass. Please refer to latam.com for complete LATAM Pass program details and regulations. LATAM Pass is solely responsible for the redemption and fulfillment of LATAM Pass Miles. LATAM Airlines may change the LATAM Pass rules, program partners, regulations, and benefits, conditions of participation or Mileage levels, in whole or in part, at any time with or without notice, ven though changes may affect the value of mileage already accumulated. LATAM Pass may withdraw, limit, modify or cancel any award, increase the Mileage required for any award, modify or regulate the transferability of awards, add an unlimited number of blackout dates or limit the number of seats available to any or all destinations. Each mile awarded through the LANPASS Visa Card is equal to 1.61 kilometers on your LATAM Pass account.
- (d) The LATAM Pass Account Number on this Account must belong to the primary Cardmember. A change to a LATAM Pass Account Number or LATAM Pass Account must be made with LATAM Pass.
- (e) LATAM Airlines is not a party to this agreement and has no authority regarding the LANPASS Visa Credit Card Account, including with respect to any extension of credit on the Account. We are solely responsible for all credit extended on the Account. LATAM Airlines is not a creditor or owner of the Account. You authorize us to share information about you and your Account with LATAM Airlines and LATAM Pass. We reserve the right to change these Reward Program rules with or without notice to you.
- (f) We reserve the right to amend or cancel the LANPASS Visa Credit Card program or change the LANPASS Visa Credit Card program benefits at any time with or without notice to you.
