Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.
	<ul> <li>Our affiliates include companies with a common corporate identity of TMG Financial Services.</li> </ul>
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
	<ul> <li>Nonaffiliates we share with can include our partners for co-branded credit card programs.</li> </ul>
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
	<ul> <li>Our joint marketing partners include companies that are our partners for co-branded credit card programs or reward programs.</li> </ul>

## Other important information

The information-sharing practices described above are in accordance with Federal law. You may have other privacy protections under state laws. We will comply to the extent applicable.

## For Vermont Residents

In accordance with Vermont law, TMG Financial Services will not share information we collect about Vermont residents to nonaffiliated third-party companies except:

- With the authorization or consent of the Vermont resident;
- To companies that perform marketing or other services on our behalf;
- Name, contact and transaction and experience information (such as your account balance and payment history) to other financial institutions with which we have joint marketing agreements; or
- As permitted by law.

## For California Residents

To the extent required by California law, TMG Financial Services will not share information we collect about California residents with companies outside of the TMG Financial Services affiliate companies except:

- · With the authorization or consent of the California resident;
- To service the member's accounts;
- To fulfill on rewards or benefits; or
- As permitted by law.
